

## COGNIZANT WELLBEING PROGRAM (THE "PROMOTION") OFFICIAL RULES AND REGULATIONS

**OVERVIEW**: Cognizant Technology Solutions is partnering with HealthCheck360 (the "Sponsor") to offer a Wellbeing Program to promote health and wellbeing within the organization. Eligible participants must register at <u>www.myhealthcheck360.com</u> or on the myHealthCheck360 app to participate in wellness challenges, submit healthy activities, complete a voluntary health screening, and receive points to qualify for a chance to win prize drawings.

- <u>DURATION</u>: The Wellbeing Program ("promotion") will start January 1, 2022 at 12:00:00 AM Central Daylight Time (CDT) and end December 15, 2022 at 11:59:59 PM Central Standard Time (CST). Voluntary Health Screenings must be submitted by November 30, 2022 at 11:59:59 PM Central Standard Time (CST).
- <u>2.</u> WHO CAN PARTICIPATE (ELIGIBILITY): Participation is open to all full-time, active associates in the U.S. ("Participant"). Part-time employees, contractors, and/or Associates outside of the U.S. are not eligible to participate. To enter and be eligible to win, Participants must be a full-time associate, be an active employee at the time of the prize drawing, and create an account in the myHealthCheck360 system. In order to be entered into the drawing, Participants must complete established activities. The promotion is void outside the 50 United States, Washington, D.C., and where prohibited by law. Promotion is subject to all applicable federal, state, and local laws.
- 3. The Website will house Participant activity throughout the Wellbeing Program, and will be where the Sponsors determines who is eligible to be entered for each prize. Instructions from the E-mail and on the Landing Page will outline the necessary actions and define how to enter for the specific prizes throughout the Promotion. The instructions will define what action to complete ("Entry") to receive one (1) entry into the Promotion for the corresponding contest's Entry Period (subject to verification with the Entry Requirements below).

**ENTRY PERIODS**: During the period beginning January 1, 2022 at 12:00:00 AM Central Daylight Time (CDT) and ending December 15, 2022 at 11:59:59 PM Central Standard Time (CST), this promotion offers a minimum of twenty (20) Entry Periods (each, an "Entry Period" and collectively the "Entry Periods"), defined on the Landing Page and E-mail. Voluntary Health Screenings must be submitted by November 30, 2022 at 11:59:59 PM Central Standard Time (CST) to qualify for the drawing.

**ENTRY LIMIT:** There is a limit of one (1) Entry per Participant per each Entry Period. Each promotion E-mail and the Landing Page will describe the entry mechanism for that Entry Period.

**GENERAL ENTRY DETAILS:** Participants must use their personal accounts on the Website to participate. Each Entry will be subject to myhealthcheck360 Terms of Use (found at https://myhealthcheck360.com/tos), and must comply with the Entry requirements set forth in this agreement. Entries may be screened by the Sponsor for apparent compliance with these

Official Rules. Presence of an Entry on the Website is not a confirmation, representation or warranty by the Sponsor or any of its representatives that the Entry is compliant with these Rules. Sponsor's decisions with respect to whether an Entry complies with these Official Rules are final and binding and may be made by Sponsor at any time. Entries that do not meet the requirements set forth in these Official Rules may not be acknowledged and may be automatically disqualified, in the sole discretion of the Sponsor and/or the Promotion Judges. Sponsor is not responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Promotion or Website or by any technical or human error which may occur in the processing of the entries.

**ENTRY REQUIREMENTS:** By submitting an Entry into the Promotion, you warrant and represent that the Entry conforms to the Official Rules, the rules set forth on the Website, and the Entry Requirements set forth herein. Entries must be in English and must be legible.

<u>4.</u> PROMOTION DRAWS AND WINNER DETERMINATION: The method of Winner Determination for this promotion will be conducted by random drawing of that Entry Period's submissions. Selected winners must be a full-time U.S. Associate at the time of the promotion drawing. Winner Determination will take place within 72 business hours of the end of each Entry Period or contest Entry Periods by judges at the Sponsor (the "Promotion Judges").

**<u>RANDOM DRAWS</u>**: The Promotion Judges will randomly select winners among all eligible, nonsuspect Entries received during the Entry Period or contest Entry Period. Non-winning entries will not carry forward to subsequent Entry Periods or drawings. There is a limit of one (1) prize per Participant per Entry Period.

**PRIZES & ODDS:** A minimum of Twenty (20) prize raffles will be available throughout the Promotion with a minimum of two-hundred (200) prizes available. The Sponsor holds the right to change prizes, prize values, and the quantity of prizes throughout the duration of the Promotion. Participants are eligible to win up to three (3) prizes throughout the Promotion. Credit submissions throughout the entry periods will qualify participants for the prizes outlined below. New employees can retroactively complete and submit credit for wellness activities that occurred in the past, excluding wellness challenges, to be eligible for prize credit requirements.



## "Prizes"

At the end of each Entry Period, a prize drawing will be completed. Each month ten (10) winners of \$300 Gift Cards will be drawn; Each Quarter five (5) winners of \$600 and twelve (12) winners of \$1,000 will be drawn; Additional winners of \$100 gift cards will be drawn for participation in company challenges.

The winner will be drawn at random from all eligible, non-suspect Entries received during each Entry Period. Prizes are not transferable or redeemable for cash and must be accepted as awarded, with no substitutions of any kind, except by the Sponsor, who reserves the right to substitute a prize (or portion thereof) of comparable or greater value, at its sole discretion.

All cash prizes are subject to be redeemed via Cognizant Technology Solutions payroll system within sixty (60) days following the Entry Period close. 5. VERIFICATION OF WINNERS & DELIVERY OF PRIZES: Judges will verify each selected winner's compliance with these Official Rules. Judges may award any prize to an alternate entrant as needed. The winner from the Entry Period will be contacted up to two (2) times by the Sponsor via the E-mail and/or a phone call no later than five (5) business days following the drawing date for the relevant Entry Period, with instructions on how to claim or receive the prize. Winners will be contacted at their Cognizant Technology Solutions work email and/or phone number up to two (2) times per prize from the Sponsor.

If a Potential Prize Winner is found to be ineligible, or not in compliance with these Official Rules and Regulations, declines to accept a prize, if Sponsor is unable to receive confirmation from a Potential Prize Winner within seven (7) business days of attempting contact, or in the event that a prize notification or prize is returned undeliverable, the prize may be forfeited.
